

COVID-19 LIABILITY RELEASE WAIVER

Participant (referred below to as "I," "me," or "my"), along with my child/children, desire to participate in an event connected with the Oklahoma Family Network ("OFN") described below (the "Activity"). In consideration of receiving a ticket, and participating in, the Activity and in recognition of OFN's reliance hereon, I agree to all the terms and conditions set forth in this Release Waiver ("Release").

Location (the "Premises"): Pumpkin Town, 6060 S. Garnett Rd, Tulsa, OK 74146

1. I am aware of the highly contagious nature of bacterial and viral diseases including the 2019 novel coronavirus disease (COVID-19)/Influenza/other infectious diseases (collectively, the "Disease") and the risk that I and my child/children may be exposed to or contract the Disease or other infectious diseases by being on the Premises and engaging in the Activity. I understand and acknowledge that such exposure or infection may result in serious illness, personal injury, permanent disability, death, and/or property damage. I acknowledge that this risk may result from or be compounded by the actions, omissions, or negligence of others, including OFN employees. I understand that while OFN has implemented preventative measures for OFN representatives, such as hand sanitation, social distancing and use of face coverings, designed to reduce the spread of the Disease, OFN cannot guarantee that I or my child/children will not become infected with the Disease or other infectious diseases while on the Premises and that being on the Premises may increase my and my child's/children's risk of contracting the Disease. **NOTWITHSTANDING THE RISKS ASSOCIATED WITH THE DISEASE, I ACKNOWLEDGE THAT I AM VOLUNTARILY ENTERING THE PREMISES WITH MY CHILD/CHILDREN TO ENGAGE IN THE ACTIVITY WITH KNOWLEDGE OF THE DANGER INVOLVED. I HEREBY AGREE TO ACCEPT AND ASSUME ALL RISKS OF PERSONAL INJURY, ILLNESS, DISABILITY, DEATH, AND/OR PROPERTY DAMAGE RELATED TO THE DISEASE, ARISING FROM MY AND MY CHILD/CHILDREN BEING ON THE PREMISES OR ENGAGING IN THE ACTIVITY, WHETHER CAUSED BY THE ORDINARY NEGLIGENCE OF OFN OR OTHERWISE.**

2. I hereby agree to hold harmless, and expressly waive and release any and all claims against, OFN, and its officers, directors, manager(s), employees, agents, affiliates, successors, and assigns (collectively, "Releasees"), on account of injury, illness, disability, or death, arising out of or attributable to my or my child/children being on the Premises or engaging in the Activity and being exposed to or contracting the Disease, whether arising out of the ordinary negligence of OFN or any Releasees or otherwise. I covenant not to make or bring any such claim against OFN or any other Releasee, and forever release and discharge OFN and all other Releasees from liability under such claims.

3. I am familiar with federal, state, and local laws, orders, directives, and guidelines related to the Disease, including the Centers for Disease Control and Prevention (CDC) guidance on the Disease. I and my child/children will comply with all such applicable orders, directives, and guidelines while on the Premises, including, without limitation, requirements related to hand sanitation, social distancing, and use of face coverings. I agree not to enter the Premises if I or my child/children are experiencing symptoms of the Disease (such as cough, shortness of breath, or fever), have a confirmed or suspected case of the Disease, or have come in contact in the last 14 (fourteen) days with a person who has been confirmed to have or suspected of having the Disease.

4. If any term or provision of this Release is invalid, illegal, or unenforceable, such invalidity, illegality, or unenforceability shall not affect any other term or provision of this Release. This Release is binding on and shall inure to the benefit of OFN and me, my child/children and our respective successors and assigns.

By accepting tickets to the Activity provided by OFN and participating in the Activity, Participant agrees to all the term and conditions of this COVID-19 LIABILITY RELEASE WAVIER.
